

**TOWN OF MONTAGUE
BY-LAW # 2010 - 03**

MAYOR & COUNCILLORS HONORARIUM BYLAW

BE IT ENACTED BY THE TOWN COUNCIL OF THE TOWN OF MONTAGUE PURSUANT TO THE MUNICIPALITIES ACT, CHAPTER M-13, R.S.P.E.I. 1988, AS FOLLOWS:

PART 1: TITLE

- 1.1 This Bylaw shall be referred to as the Town of Montague Mayor and Councillors Honorarium Bylaw:

PART 2: PURPOSE

- 2.1 The purpose of this bylaw is to establish rates of remuneration for the offices of Mayor and Councillor for the Town of Montague.

PART 3: HONOURARIUM

- 3.1 Effective November 16, 2010, the annual honorarium to be paid to the Mayor of the Town of Montague shall be six thousand dollars (\$6,000.00), and be available to the Mayor monthly, quarterly, bi-yearly, or yearly as desired following time served.
- 3.2 Effective November 16, 2010, the annual honorarium to be paid to each Councillor of the Town of Montague shall be four thousand five hundred dollars (\$4,500.00), and be available to the Councillor monthly, quarterly, bi-yearly, or yearly as desired following time served.

PART 4: EXPENSES

- 4.1 One third of the honorarium paid to the Mayor and each Councillor is considered to be an allowance for expenses incidental to the discharge of the duties of an elected official and exempt from taxation under Section 81(2) and (3) of the Income Tax Act.

PART 5: REPEAL

- 5.1 All former Town Council Salary or Honorarium Bylaws of the Town of Montague are hereby repealed.

EFFECTIVE DATE

The effective date of the Bylaw is the date on which the bylaw was adopted by Town Council.

FIRST READING

This Bylaw was read a first time by a majority of Councillors present at the Council meeting held on the 16 day of August, 2010.

This Bylaw was approved by a majority of the Councillors present at the Council meeting held on the 16 day of August, 2010.


SECOND READING

This Bylaw was read a second time by a majority of Councillors present at the Council meeting held on the 13 day of September, 2010.


This Bylaw was approved by a majority of the Councillors present at the Council meeting held on the 13 day of September, 2010.

This Bylaw was adopted and approved by a majority of the Councillors present at the Council meeting held on the 13 day of September, 2010.


